RICHMOND, CALIFORNIA, October 5, 2021

The Richmond City Council Evening Open Session was called to order at 5:30 p.m. by Mayor Thomas K. Butt via teleconference.

Due to the coronavirus (COVID-19) pandemic, Contra Costa County and Governor Gavin Newsom issued multiple orders requiring sheltering in place, social distancing, and reduction of person-to-person contact. Accordingly, Governor Gavin Newsom issued Assembly Bill 361 that allowed cities to hold public meetings via teleconferencing.

DUE TO THE SHELTER IN PLACE ORDERS, attendance at the City of Richmond City Council meeting was limited to commissioners, essential City of Richmond staff, and members of the news media. Public comment was confined to items appearing on the agenda and was limited to the methods provided below. Consistent with Assembly Bill 361, this meeting utilized teleconferencing only. The following provides information on how the public participated in the meeting.

City Attorney Teresa Stricker stated there were no final actions to report.

REPORT FROM THE CITY MANAGER

City Manager Laura Snideman made the following announcements: The Community Service Department's Healthy Lunches for Seniors Program was providing meals by calling (510) 307-8085. The Council requested a report on updates from the Reimaging Public Safety Task Force be placed on the City Council agenda for the third Tuesday of every month. Hulan Barnett and Norma (last name not stated) gave comments via teleconference.

RECENT CRIME REPORT FROM THE CHIEF OF POLICE

Chief of Police Bisa French reported the following Richmond police incidents that occurred within the last week: one homicide, four shootings, three robberies, six felony domestic assaults, and the recovery of six firearms. Discussion ensued. The Council recommended staff review the City of Fairfield's ordinance regarding fining sideshow spectators to develop a similar ordinance for Richmond. The following individuals gave comments via teleconference: Leisa Johnson, Michael Parker, Hulan Barnett, and Ali Estrada.

ABATEMENT REPORT FROM THE PUBLIC WORKS DIRECTOR

Public Works Director Joe Leach reported on the abatement and cleanup events at the following locations: Richmore Village/Metro neighborhood; Interstate-80/Central Avenue underpass encampments and alleys; Esmond Avenue alley; and illegal dumping and graffiti in various locations. Mr. Leach acknowledged the Public Work Department's abatement team, Richmond Police Department, and the Police Activities League for assistance with abatement. Discussion ensued. The Council requested staff to address the cleanup issues under the overpass entering Richmond and the vacant lot located at Carlson Boulevard and Florida Avenue. The Council recommended hiring youth and utilizing the American Rescue Plan Act funds for cleanup. The following individuals gave comments via teleconference: Leisa Johnson, Karla Perez, Jessi Taran, Hulan Barnett, and Michael Parker.

OPEN FORUM FOR PUBLIC COMMENT

The following individuals gave comments via teleconference:

Joey Schlemmer gave comments regarding the Richmond Police Department's emergency dispatching center and how calls were handled. Mr. Schlemmer expressed concerns regarding the future handling of fire and medical dispatching currently provided in Richmond.

Karla Perez and Leisa Johnson recommended the resignation or removal of Richmond Reimagining Public Safety Task Force member, Tamisha Walker, due to a recently publicized incident.

Tarnel Abbott, Roxanne Garza, and Michael Littleton gave comments regarding Item I-9. Ms. Abbott expressed support for hiring a credentialed library director through a nationwide search, full staffing, and reinstatement of open hours at the library. Ms. Garza raised questions concerning the proposed community engagement director position and the implementation of the Racial Equity Action Plan presented at the June 22, 2021, City Council meeting. Mr. Littleton expressed support for the current deputy city manager.

Jessi Taran expressed concerns regarding the new site management for the unhoused individuals on Rydin Road and the lack of options for relocation. Ms. Taran recommended utilizing vacant lots in Richmond for housing.

Rodney Brown gave comments in support of Item I-17. Mr. Brown invited the Council and community to attend the Soulful Softball Sunday tournament scheduled for 9:00 a.m. on October 17, 2021, at Nicholl Park.

Melvin Willis invited the community to email him at <u>melvinforrichmond@gmail.com</u> to move issues to the forefront. Mr. Willis encouraged the community to reach out to him and staff regarding the RecycleMore Joint Powers Authority (JPA) and announced that the next JPA meeting was scheduled for October 14, 2021, at 6:00 p.m. via Zoom teleconference to discuss dumping and solid waste issues. Mr. Willis expressed support for the reports from the city manager, police chief, and public works director made during the meeting and advised that he may introduce rule changes to receive the information without speaking to the issues.

CITY COUNCIL CONSENT CALENDAR

On motion of Vice Mayor Johnson III, seconded by Councilmember Martinez, the items marked with an (*) were approved by the unanimous vote of the City Council:

***I-1.** Approved contract amendment No. 1 with Larry Walker Associates in the amount of \$320,000, for a total amount not to exceed \$520,000 to assist with the Environmental Compliance Program Inspections, Sampling, and the City of Richmond's National Pollutant Discharge Elimination System and Stormwater Municipal Regional Permit.

I-2. The matter to adopt a resolution authorizing the issuance of a task authorization to Veolia Water to manage (on behalf of the City of Richmond) subcontracts with W.R. Forde and Associates, VW Housen, and Questa Engineers to replace and/or rehabilitate specific sanitary sewer pipelines in an amount not to exceed \$474,274.50 was introduced by Public Works Project Manager Mary Phelps. W.R. Forde and Associates project cost of \$317,000 plus 16.5 percent mark-up of \$52,305, plus 15 percent contingency of \$47,550 plus 9 percent mark-up of \$4,279.50; VW Housen project cost of \$25,000, plus 16.5 percent mark-up of \$4,125, plus 15 percent contingency of \$3,750, plus 9 percent mark-up of \$337.50; and Questa Engineers project cost of \$15,000, plus 16.5 percent mark-up of \$2,475, plus 15 percent contingency of \$2,250, plus 9 percent mark-up of \$202.50. Leisa Johnson gave comments via teleconference. Discussion ensued. On motion of Vice Mayor Johnson III, seconded by Councilmember Willis, adopted Resolution No. 115-21 by the following vote: Ayes: Councilmembers Bates, McLaughlin, Willis, Vice Mayor Johnson III, and Mayor Butt. Noes: None. Abstained: Councilmembers Jimenez and Martinez. Absent: None.

I-3. The matter to adopt a resolution to appropriate budget from the 2019A Wastewater Bonds proceeds for the unanticipated work; and approve contract amendment No. 1 for Bay Hawk Inc., in the amount of \$224,750 for the sewer pipeline repairs as listed in the 2018/2019 Risk Assessment Analysis Clean-up Proposal Project list for a total contract amount not to exceed \$598,750 was introduced by Public Works Project Manager Mary Phelps. Leisa Johnson gave comments via teleconference. Discussion ensued. On motion of Vice Mayor Johnson III, seconded by Councilmember Willis, adopted **Resolution No. 116-21** by the following vote: **Ayes:** Councilmembers Bates, McLaughlin, Willis, Vice Mayor Johnson III, and Mayor Butt. **Noes:** None. **Abstained:** Councilmembers Jimenez and Martinez. **Absent:** None.

***I-4.** Approved a contract with Pisor Fence Division, Inc., for replacing the existing damaged fence at the Wastewater Treatment Plant (601 Canal Boulevard) with a new 1,120 linear foot of 8-foot height fence filled with Green Vinyl Strips, in an amount not to exceed \$128,070 (project cost of \$121,393 plus 5.5 percent contingency of \$6,677).

On motion of Vice Mayor Johnson III, seconded by I-5. Councilmember Willis, adopted Resolution No. 117-21 authorizing the issuance of a task authorization to Veolia Water to manage (on behalf of the City of Richmond) subcontracts with: D'Arcy and Harty Construction, Inc., VW Housen, and Questa Engineers to replace and/or rehabilitate specific sanitary sewer pipelines in an amount not to exceed \$956,440 by the following vote: Ayes: Councilmembers Bates, McLaughlin, Willis, Vice Mayor Johnson III, and Mayor Butt. Noes: None. Abstained: Councilmembers Jimenez and Martinez. Absent: None. D'Arcy and Harty project cost of \$680,000 plus 16.5 percent mark-up of \$112,200, plus 15 percent contingency of \$102,000 plus 9 percent mark-up of \$9,100; VW Housen project cost of \$25,000, plus 16.5 percent mark-up of \$4,125, plus 15 percent contingency of \$3,750, plus 9 percent mark-up of \$337.50; and Questa Engineers project cost of \$15,000, plus 16.5 percent mark-up of \$2,475, plus 15 percent contingency of \$2,250, plus 9 percent mark-up of \$202.50.

*I-6. Adopted **Resolution No. 118-21** authorizing the city manager or designee to enter into a Maintenance Agreement with Caltrans. The City of Richmond will be responsible for maintaining the signage and striping improvements that were installed at the intersection of Harbour Way South and Hoffman Boulevard.

I-7. The matter to approve contracts with: (1) Avery and Associates; (2) The Byers Group; (3) Cooperative Personnel Services; (4) Koff and Associates; and (5) Management Partners each for \$75,000 for executive recruitment services over a three-year period from September 28, 2021, to September 27, 2024, was introduced by Interim Human Resources Director Marc Fox. Discussion ensued. A motion was made by Councilmember Willis, seconded by Vice Mayor Johnson III, to approve said contracts. A substitute motion made by Councilmember Martinez, seconded by Councilmember Bates, lowered the authorized contracts amounts from \$75,000 to \$50,000 by the following vote: **Ayes:** Councilmembers Bates, Jimenez, Martinez, McLaughlin, Willis, and Vice Mayor Johnson III. **Noes:** Mayor Butt. **Abstained:** None.

***I-8.** Adopted **Resolution No. 119-21** amending the salary schedule to acknowledge the Richmond Fire Management Association executing the option to move a differential pay into base salary.

I-9. Withdrawn from the agenda, the matter to approve the Fiscal Year 2021-22 multi-year comparative position listing and amend the salary schedule to implement the city manager's reorganization of specific city departments.

*I-10. Approved two legal services agreements, first amendments to five legal services agreements, and two second amendments to existing legal services agreements with: (1) Liebert, Cassidy Whitmore; (2) Sloan Sakai Yeung & Wong LLP; (3) Maloney Employment Law; (4) Orbach, Huff, Suarez & Henderson; (5) McNamara, Ney, Beatty, Slattery, Borges & Ambacher; (6) Newdorf Legal; and (7) Allen Glaessner Hazelwood & Werth to represent the City of Richmond in pending and future employment, dangerous condition, police/tort defense and other municipal law litigation in state and federal court.

The matter to adopt a resolution authorizing the city I-11. manager to execute a professional services agreement for Municipal Advisor services for land-secured financing districts if and when needed with any of the following firms (listed alphabetically): KNN Public Finance, LLC; NHA Advisors, LLC; Public Resources Advisory Group, Inc. was introduced by Public Works Director Joe Leach. Professional services agreements for as-needed services were for individual amounts not to exceed \$100,000 over a three-year period, with an option to extend the contract for two years. Total authority was limited to \$300,000 maximum, with no single contract exceeding \$100,000. The list and limits may be revised, amended, or canceled by the action of the City Council, including by resolution for the issuance of bonds. Regional Government Services Advisor Tracy Fuller provided an oral report. Discussion ensued. A motion was made by Councilmember Martinez to exclude landscaping and lighting districts, community facility districts, and tax-exempting financial mechanisms. Further discussion ensued. Sally Tobin and Jim Hanson gave comments via teleconference. An amended motion made by Councilmember McLaughlin, seconded by Councilmember Martinez, adopted **Resolution No. 120-21** with an additional whereas clause after the tenth whereas clause stating, "... and; WHEREAS, the City Council shall review the benefits and risks of any proposed land-secured financing district prior to initiation of Municipal Advisor consulting services and may approve, disapprove, revise, amend or cancel the nature and scope of work", passed by the following vote: Ayes: Councilmembers Bates, Jimenez, Martinez, McLaughlin, Willis, and Vice Mayor Johnson III. Noes: Mayor Butt. Abstained: None. Absent: None.

***I-12.** Approved and authorized the Police Department to spend up to \$50,000 per vendor over the next three (3) years. The four vendors were chosen based upon their ability to source and provide, at a reasonable cost, the ammunition sizes utilized by the department. The four vendors were: Dooley, LC Action, San Diego Police Supply, and Ammo.com.

I-13. The matter to approve a sole-source agreement with the Contra Costa County District Attorney's Office for the continued and dedicated services of a deputy district attorney specifically assigned as Richmond's Community Based Prosecutor, in an amount not to exceed \$100,000 from July 1, 2021, through June 30, 2022, was introduced by Chief of Police Bisa French. Discussion ensued. The Council requested a report for how many other cities were paying for district attorney services including the services provided to Richmond compared to other cities. On motion of Vice Mayor Johnson III, seconded by Councilmember McLaughlin, approved said agreement by the following vote: **Ayes:** Councilmembers Jimenez, Martinez, McLaughlin, Willis, Vice Mayor Johnson III, and Mayor Butt. **Noes:** Councilmember Bates. **Abstained:** None. **Absent:** None.

(At approximately 11:00 p.m., on motion of Vice Mayor Johnson III, seconded by Mayor Butt, extended the meeting to complete the discussion for Item I-13 by the following vote: Ayes: Councilmembers Bates, Jimenez, Martinez, McLaughlin, Vice Mayor Johnson III, and Mayor Butt. Noes: Councilmember Willis. Abstained: None. Absent: None). ***I-14.** Approved a three-year contract with the Richmond Rod & Gun Club in an amount not to exceed \$35,000 for ongoing training and practice.

***I-15.** Authorized the city manager or designee to execute a grant agreement with the State Department of Parks and Recreation for a \$25,000 Certified Local Government (CLG) grant and appropriated the \$25,000 CLG grant in the Fiscal Year 2021-2022 budget.

***I-16.** Approved a sole-source contract with PES Environmental, Inc. in an amount not to exceed \$70,000 for environmental consulting services related to the Miraflores property, through June 30, 2023, to be paid for by funding from the Successor Agency to the Richmond Community Redevelopment Agency.

*I-17. Approved a request to waive the rental fees in the amount of \$873.50 for the 2021 Soulful Softball Sunday games and activities scheduled for October 17, 2021, at Nicholl Park.

***I-18.** Proclamation declaring October 16, 2021, as Arbor Day in the City of Richmond.

***I-19.** Proclamation declaring October 6, 2021, as California Clean Air Day in the City of Richmond.

COUNCIL AS A WHOLE

The matter to direct staff to complete negotiations J-1. with: (a) City National Bank ("CNB") with respect to a Loan Agreement to refinance the 2005 Bonds and Swaps and (b) Royal Bank of Canada ("RBC") with respect to amending the Swaps and, if concluded satisfactorily, to bring an authorizing resolution and associated documents to the City Council for adoption as soon as feasible, optimally in fewer than 75 days was introduced by City Manager Laura Snideman. Joe Mortenson of the Public Resources Advisory Group, George Majors of the Majors Group, and Bond Counsel John Palmer of Orrick presented a Powerpoint that highlighted the following: Pension obligation bonds problems to solve and challenges; overview of alternatives, estimated costs, and alternatives not analyzed; risks, advantages, and sole sourcing of a CNB loan structure; recommendations; and next steps. Discussion ensued. A motion was made by Councilmember McLaughlin, seconded by Councilmember Jimenez, to move forward with finding a firm to conduct a peer review, by sole-source or emergency procurement if either of those categories moved the process faster, and bring back the analysis to the Council for a final decision. Norma (last name not stated) and Lisa Cody gave comments via teleconference. The motion passed by the following vote: Aves: Councilmembers Jimenez, Martinez, McLaughlin, and Willis. Noes: Mayor Butt. Abstained: Councilmember Bates and Vice Mayor Johnson III. Absent: None.

Hi all,

Just wanted to comment that I was disappointed by the City Council's recent decision to side with the anti-housing groups suing Richmond over the prospective development at Point Molate. By instructing the City Attorney to go along with the plaintiffs' dubious claims, the Council may have caused Richmond to violate contractual obligations, and exposed the city to further costly litigation. I'm concerned by the potential repercussions of this risky move.

Beyond the legal issues, I hope that the RPA members on the City Council will reconsider what often seems like reflexive opposition to increasing the city's housing supply. Dear Mayor, Vice Mayor, Council and Staff:

On September 15, 2021, the governor signed into law AB 361, an urgency measure which largely continues the executive orders allowing for remote meetings. The Governor subsequently issued an order making the provisions of AB 361 effective beginning **October 1**, **2021.**

AB 361 contains several requirements in order to continue the use of remote meetings, including that the Council must reconsider the factors to continue remote meetings **every 30** days.

Last week, on October 26th, the City Council voted for the **first time** to extend their ability to continue remote meetings for 30 days, which as I would understand it would have covered the month of October.

We are now into November. As such, I would like for the City Attorney to clarify for the public why there is not another new vote tonight to cover the next 30 days proactively, as all other public bodies in the Bay Area are doing.

Importantly, the community wants to see this council go to a hybrid format whereby the Council and key staff are present at City Hall and the community and other participants can participate remotely via Zoom (as several other public bodies are doing).

As I have stated several times, the community is tired of council members shutting off their videos for the vast majority of the meeting and believe this is in violation of the Brown Act.

Indeed, the Mayor uses the camera views to state at the beginning of the city council meeting that it looks like a quorum has been met so that the meeting can begin. Having cameras live is the only way for the Public to know whether or not quorum has been met and is being maintained throughout the course of the meeting.

Moreover, we are tired of watching certain councilmembers talk to their spouses or be on their phones or computers throughout the course

None of these actions are allowed when you are on the dais at city hall and they should not be allowed on Zoom.

The best way to respect the Public and bring decorum back to the dais is to commence hybrid meetings, and this should happen ASAP just as with other public boards.
