Subject:	Five-Year Contract with NEOGOV to Provide Police Department Services.
FINANCIAL IMPACT:	The total five-year contract amount of \$100,000 includes an approximate \$8,000 contingency. \$17,450 is estimated for the first year of the contract and is included in the approved Police Department budget for fiscal year 2022-2023. Subsequent fiscal years will be budgeted for appropriately (01191021-400209).
PREVIOUS COUNCIL ACTION:	November 13, 2012 – a 3-year, \$22,702.30 contract with PowerDMS (now a subsidiary of NeoGov) went to City Council, but since then, the annual contract amount has been under \$10k per fiscal year and approved via a short form contract.
STATEMENT OF THE ISSUE:	The Police Department is seeking approval for a five-year contract with NEOGOV to provide automated Customer Notification (subscription) and informational services for citizens and to provide Online Training and Policy Management for Police Department's Personnel and Training Unit.

DISCUSSION:

Starting in 2012, the City contracted with PowerDMS to provide police policy management software services. PowerDMS stores and keeps the data on their servers reducing the data storage required by PD servers. The services make it easy to track required officer training and testing. Continuing the use of PowerDMS services will allow City staff to review data going back to the inception date of the original contract, build upon the data already saved, and access historical data for tracking and compliance audits. In December 2020, PowerDMS was purchased by NEOGOV.

Following best practices set forth by Purchasing, the police department issued a Request for Proposals (RFP) in November of 2021 to seek bids regarding community surveys and notification services. Of the 509 notified vendors, two (2) vendors responded with bids - SpidrTech and Cuehit. Using a rating matrix, Cuehit scored a total of 265 points compared to SpidrTech's 230 points. During the review process, the police department found that Cuehit is able to provide the same services (e.g., community survey and notification services) that we had received up until June 30, 2022, but with an estimated \$170,000 cost savings over the five-year contract term.

After choosing Cuehit, Cuehit was acquired by NEOGOV. Since NEOGOV also purchased PowerDMS, we can now contract with NEOGOV for both services and consolidate the two contracts into one.
