**SCOPE OF WORK**

The Contractor shall perform additional work as of the result of the poor condition of the subgrade. The Contractor is also addressing asphalt repair work on trenches done by EBMUD and additional paving slope resulting from street slope varying from the ones in the drawing. The Project will directly reduce Greenhouse Gas (GHG) emissions through a combination of tree planting, energy use reduction from shading adjacent buildings and reduced vehicle miles traveled. Payment will be made on a bid item basis for installed cost for bid items including labor, materials, and equipment needed for work.
