

RESOLUTION NO. XX-22

**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,
CALIFORNIA, APPROVING THE APPROPRIATION OF \$2,200,000 FROM THE 2022-
23 SB1 FUND BALANCE TO THE 2022-23 PAVING PROGRAM**

WHEREAS, Senate Bill 1 (SB 1), the Road Repair and Accountability Act of 2017 (Chapter 5, Statutes of 2017) was passed by the Legislature and signed into law by the Governor in April, 2017, in order to address the significant multi-modal transportation funding shortfalls statewide; and

WHEREAS, SB 1 includes accountability and transparency provisions that will ensure the residents of our City are aware of the projects proposed for funding in our community and which projects have been completed each fiscal year; and

WHEREAS, the City must include a list of all projects proposed to receive funding from the Road Maintenance and Rehabilitation Account (RMRA), created by SB 1 by resolution, which must include a description and the location of each proposed project, a proposed schedule for the project's completion, and the estimated useful life of the improvement; and

WHEREAS, the City will receive an estimated \$2,510,376 in RMRA funding in Fiscal Year 2022-23 from SB 1; and

WHEREAS, on September 13, 2022, City Council approved the 2022-23 SB1 list of Regional Collectors to be resurfaced including:

- Richmond Parkway: On Westbound from Lakeside Dr. to 1200 feet easterly.
- Richmond Parkway: On Eastbound from San Pablo Avenue to Lakeside Dr.
- San Pablo Avenue: On Southbound between Richmond Parkway and Hilltop Drive.
- San Pablo Avenue: On Northbound from El Cerrito City Limits to Northerly I-80 Right of Way.

WHEREAS, there are several Castro Street sections that required immediate resurfacing before next Winter 2023; and

WHEREAS, the Richmond Parkway sections listed above were resurfaced during the month of September 2022 and exhausted the current \$1,000,000 SB1 2022-23 budget allocation; and

WHEREAS, there is an additional \$2,200,000 SB1 fund balance for 2022-23 that needs to be appropriated to resurface sections on San Pablo Avenue and Castro Street; and

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Richmond hereby confirms the foregoing recitals are true and correct.

BE IT FURTHER RESOLVED the previously proposed and adopted projects may utilize Fiscal Year 2022-23 Road Maintenance and Rehabilitation revenues in their delivery. With the relisting of these projects in the adopted fiscal year resolution, the City is reaffirming to the public and the State our intent to fund these projects with Road Maintenance and Rehabilitation Account revenues:

Funding of portions of the following projects:

- Richmond Parkway: On Westbound from Lakeside Dr. to 1200 feet easterly.
- Richmond Parkway: On Eastbound from San Pablo Avenue to Lakeside Dr.
- San Pablo Avenue: On Southbound between Richmond Parkway and Hilltop Drive.
- San Pablo Avenue: On Northbound from El Cerrito City Limits to Northerly I-80 Right of Way.
- Castro Street at various location

These pavement rehabilitation improvement projects are anticipated to have a useful life of 20 years and are anticipated to begin in October 2022, and be completed by June 30, 2023.
