Subject:	Richmond Fund for Children and Youth Request for Proposal (RFP) Fiscal Year 2023-2024
FINANCIAL IMPACT:	Article 15, Section 2 of the City of Richmond Charter required an allocation of one, two, and three percent of the City's General Fund in Fiscal Year (FY) 2021-2022, FY 2022-2023, and FY 2023-2024 respectively, and three percent each fiscal year thereafter through FY 2027-2028 to the RFCY (13371018-399194). The FY 2021-2022 allocation was ~\$1.88 million based on one percent of the \$188 million General Fund (GF) allocation. During the FY 2022-23, the allocation will be ~\$4.13 million based on two percent of the \$206.6 million GF Revenue to support both the initial FY 2021-2022 grantees and the FY 2022-2023 grantees. Utilizing the same FY 2022-2023 GF Revenue numbers to estimate the available three percent allocation for FY 2023-2024, RDCY staff is estimated at ~\$6.2 million (three percent of \$206.6 million GF revenue estimate) for FY 2023-2024. Additionally, based on the Charter language, 90 percent of the three percent allocation (~\$5.58 million) will be utilized to directly support grants to youth-serving organizations. The remaining 10 percent supports the administration functions of the Department of Children and Youth.

PREVIOUS COUNCIL ACTION:	December 15, 2020; December 21, 2021
STATEMENT OF THE ISSUE:	On June 5, 2018, Richmond voters approved Measures E and K, known as the Richmond Kids First Initiative, which approved a City of Richmond charter amendment to create a Department of Children and Youth, and required that a portion of the General Fund be set aside to fund youth programs and services. At its meeting on December 5, 2022, the Richmond Fund for Children and Youth (RFCY) Oversight Board approved and authorized the release of the Fiscal Year (FY) 2023-2024 RFCY Request for Proposal on or before January 3, 2023.
RECOMMENDED ACTION:	ACKNOWLEDGE the proposed January 3, 2023, release of the Richmond Fund for Children and Youth Fiscal Year 2023-2024 Request for Proposals to support a competitive grant process to fund youth-serving organizations – Department of Children and Youth (LaShonda White/Patrick Seals 510-620-6512).

#### **DISCUSSION:**

On June 5, 2018, Richmond voters approved Measure E and Measure K, known as the Richmond Kids First Initiative, which approved a City of Richmond charter amendment (Article 15) and authorized the creation of the Richmond Department of Children and Youth ("Department") and the Richmond Fund for Children and Youth ("Fund") to provide increased and dedicated funding for children, youth, and young adult services. The ballot initiative also authorized the establishment of a 15-member oversight board ("Board") and required that the Department conduct a community needs assessment (CNA) that would guide the development of the strategic investment plan (SIP) and the first three-year grant cycle of the Fund. On December 5, 2020, City staff presented and received approval for the various components of the Request for Proposals (RFP) for Fiscal Year (FY) 2021-2024. The Board subsequently recommended and City Council approved the Department entering into grant agreements with 20 non-profit and public agencies in the amount of approximately \$1.6 million for programming in Fiscal Year (FY) 2021-2022, and 19 non-profit and public agencies in the amount of approximately \$1.4 million for programming in FY 2022-2023.

### Community Needs Assessment and Strategic Investment Plan

The CNA provided a comprehensive overview of the needs of Richmond children and youth and their families. The funding priorities in the SIP were based on the CNA and input from the community. Based on the information collected, six areas were identified as funding priorities. The six priority areas, which will remain in effect for the current RFP release, were then assigned a percentage allocation based on considerations of the urgency of the need and potential for equity impact.

PRIORITY AREAS (Not listed in order of importance)	% ALLOCATION
1. Behavioral Health: Mental Health and Wellness	20%
2. Education Support and Employment/Training Support	20%
3. Out of School Time, Afterschool, Sports and Enrichment	20%
4. Youth Violence Prevention	20%
5. Access to Basic Needs	10%
6. Information, Guidance and Case Management	10%

Once grant award decisions are finalized, the allocation amounts, as shown above, may vary slightly, depending upon the type and number of grant applications submitted, and grants awarded in each priority area. In addition, it is important to note that per the Charter, any change in an approved SIP, which could include the priority areas and allocations, shall be based on the community needs assessment and input from the community.

### FY 2023-2024 RFCY Eligibility and Structure

Organizations that receive RFCY grants are awarded grants based on one of the six priority areas, and for an initial one-year period (July 1<sup>st</sup> - June 30<sup>th</sup>). City staff recommended and the Board approved the concept that the initial grants could be renewed for up to two additional one-year periods between July 1, 2021 – June 30, 2024, contingent on the past year's grant performance and availability of funds. The available funds for grants, from both new and renewed applicants, in year three will increase based on the funding allocations outlined in the Charter. As outlined in the Financial Impact section of this report, City staff is estimating a total of ~\$5.58 million will be available for grant awards. This amount will provide a third year of grants for FY 2021-2022 approved grantees, a second year of grants for FY 2022-2023 approved grantees, and first year grants for FY 2023-2024 grantees.
