PROCEDURE

Your request will then be restrictive and non-competitive, and will fall into a sole source category. If the sole source justification is approved, the requisition can be expedited without the normal bidding requirements.

Such a request should not be made unless you are confident that your request is reasonable and appropriately justified to meet the City's requirements and withstand any possible audit. The City's requirements and the format for submitting such requests are contained herein. Sole Source form must be signed by authorized department representative(s). The certification will remain on file for audit purposes.

The following factors DO NOT apply to sole source requests and should not be included in your sole source justification. They will not be considered and only tend to confuse the evaluation process.

The MAGNUSWOTXTM APP is built on a proprietary methodology developed by the RippleWorx team which uses various assessments and measures to evaluate the holistic well-being of the officer in real time. These assessments, created and distributed through the mobile APP, allow for the rapid classification of inputs and measures to allow our algorithm to detect slight anomalies that might require attention. Each classification is tied to a sensor that will activate or alarm when the demands on this sensor outpace the resources for that classification.

Once a sensor is alerted, it will continue to notify the designated provider until the resources and demands come back into balance as measured through the continued assessments.
