Subject:	CivicSpark AmeriCorps Fellows Second Contract Amendment
FINANCIAL IMPACT:	The contract for two CivicSpark AmeriCorps fellows in the amount of \$44,000 is proposed to be funded by the following two funding sources: 1) \$22,000 from the Environmental and Community Investment Agreement for implementation of the City's Climate Action Plan (11771018 400201 2A1AA); and 2) \$22,000 from the Republic Services Franchise Fee (01362765 400201 2GI01).
PREVIOUS COUNCIL ACTION:	July 26, 2022
STATEMENT OF THE ISSUE:	CivicWell (formally Local Government Commission) has "CivicSpark" AmeriCorps fellows available for placement with local governments, public agencies, and other nonprofits to work on energy and climate projects during the Fiscal Year (FY) 2023-2024 service year. The City has served as a placement site for approximately 10 years and has been very satisfied with the fellows work and the reciprocal relationship.

DISCUSSION:

Background

CivicSpark is a Governor's Initiative AmeriCorps program dedicated to building capacity for local public agencies to address community resilience issues such as climate change, water resource management, housing, and mobility. CivicSpark is a program of CivicWell (formally Local Government Commission) in partnership with the State of California through the Office of Planning and Research, and California Volunteers.

CivicWell provides training, support, AmeriCorps payroll and administrative services, recruitment, and placement of CivicSpark fellows as part of the service contract. The City of Richmond received a placement of two CivicSpark AmeriCorps fellows for the 2023-2024 program year. The CivicSpark program is administered by CivicWell and the California Volunteers Associations. The contract commences on January 2024 through December 2024. The Three-Quarter Time (TQT) CivicSpark fellowship costs \$22,000 for each full-time fellow with a 7.5-month fellowship term. The City has served as a placement site for 10 years and has been very satisfied with the Fellows' work.

The original contract started September 1, 2021. The contract was first amended on September 1, 2022, for time and funding threshold. The full amount of the first amendment was not expended as a second fellow was not hired. This second amendment will be for time and to increase the contract threshold amount.

The two CivicSpark Fellows assigned to the Richmond Environmental and Health Initiatives Division will be dedicated to implementation of the City's Climate Action Plan (CAP). Both Fellows will focus on the continued development of the City's Climate Action Plan open data platform (www.transparentrichmond.org). Separately, one Fellow will focus on renewable energy generation and Zero Net Energy while the other Fellow will focus on SB 1383 outreach and Zero Waste initiatives. The project will interface with the public and decision makers by leveraging and integrating the City's existing software systems with the City's Climate Action Plan and will also assist in the implementation of zero waste and energy programs with residents, businesses, and governmental facilities.

POLICY SYNERGIES

2023 City Council Priority Goal 4.3 Reduce illegal dumping

General Plan 2030

- Goal EC1: Leadership in Managing Climate Change. Take steps to address climate change and to manage its effects. This entails not only pursuing ground-breaking programs and innovative strategies but educating residents and businesses about these actions and actively monitoring results to ensure progress in critical areas. Partner with other jurisdictions and organizations to develop effective regional solutions and regulation at regional, state, and federal levels. Collaborate with residents, businesses, public agencies, and neighboring jurisdictions, to meet or exceed state requirements for reductions in greenhouse gas emissions.
- Action EC1.B: Public Awareness and Education Program. Develop a program to educate and inform residents and businesses about key climate change challenges and potential solutions. Develop and disseminate information on topics such as waste reduction, recycling, green buildings and landscaping, and renewable energy generation. Utilize a range of tools including fact sheets, website newsletters, advertising, and workshops to reach potential audiences. The program should be reviewed and evaluated periodically for effectiveness. The public awareness and education program should be incorporated into the climate action plan.
