BE IT FURTHER RESOLVED THAT, The City Council authorizes the City Manager or their designee to execute in the name of the City of Richmond, the Grant Agreement, and all other documents required by the CalTrans for participation in the Clean California Program, and any amendments thereto and accept and appropriate the grant funds.
