**RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,
CALIFORNIA, AUTHORIZING THE SECOND AMENDMENT OF FEHR & PEERS
ON-CALL TRANSPORTATION SERVICES CONTRACT TO INCREASE THE
CONTRACT NOT-TO-EXCEED AMOUNT BY \$450,000 FOR THE REMAINDER OF
THE FIVE-YEAR CONTRACT**

WHEREAS, the Richmond Public Works Department has numerous capital improvement projects funded by Federal and State Grants, Gas Tax, Measure J Funds, Gas Tax and General Fund that require the use of On-Call Transportation Services; and

WHEREAS, on June 30, 2020, Fehr & Peers (Richmond Transportation Consultant Company) was one of six On-Call Transportation Services consultants selected for a three-year contract with an option to extend for two additional years; and

WHEREAS, on June 30, 2023, the City Manager approved the first amendment to the On-Call Transportation Services contracts term and service plan extending the term for the additional two years until June 30, 2025; and

WHEREAS, Fehr & Peers is the Transportation consultant of record for several multi-year transportation and Capital Improvement Program projects; and

WHEREAS, some of these projects are already in construction and still require Fehr & Peers construction support; and

WHEREAS, other projects are in the middle of their project development processes that require additional Fehr & Peers Transportation Services to get the projects to completion or grant applications submitted; and

WHEREAS, Fehr & Peers' current funding allocation is nearly depleted to continue delivering the projects on schedule; and

WHEREAS, staff is now seeking Council approval to increase by \$450,000 the amount of Fehr & Peers Service contract for a total not-to-exceed amount of \$900,000; and

WHEREAS, the Richmond Public Works Department will continue to efficiently manage the Fehr & Peers contract, as amended.

NOW, THEREFORE, BE IT RESOLVED that the Council of the City of Richmond, California, hereby authorizes the Richmond Public Works Department to amend the Fehr & Peers contract by \$450,000 to an amount not to exceed \$900,000.
