AN ORDINANCE OF THE CITY COUNCIL OF THE CITY OF RICHMOND AMENDING CHAPTER 7.04 TO THE CITY OF RICHMOND MUNICIPAL CODE ENTITLED "BUSINESS LICENSES"

The City Council of the City of Richmond do ordain as follows:

SECTION 1. Section 7.04.130 of the City of Richmond Municipal Code is hereby amended to read as follows:

SECTION 2. Section 7.04.205 of the City of Richmond Municipal Code is hereby amended to read as follows:

7.04.205 Tax Rates for Class A through Class J, and Class P —Progressive Rates

K. Class P. Persons engaged in Class P business activities shall pay a business tax as follows:

If annual gross receipts are:	Then the business tax is:
Not over \$1,000,000	\$1.20 per \$1,000 of annual gross receipts
Over \$1,000,000 but not over \$2,500,000	\$1,200, plus \$1.50 per \$1,000 of annual
Over \$1,000,000 but not over \$2,500,000	gross receipts over \$1,000,000
Over \$2,500,000 but not over \$25,000,000	\$3,450, plus \$1.90 per \$1,000 of annual
Over \$2,300,000 but not over \$23,000,000	gross receipts over \$2,500,000
Over \$25,000,000 but not over \$50,000,000	\$46,200, plus \$2.20 per \$1,000 of annual
Over \$23,000,000 but not over \$30,000,000	gross receipts over \$25,000,000
Over \$50,000,000	\$101,200, plus \$2.40 per \$1,000 of annual
Over \$50,000,000	gross receipts over \$50,000,000

SECTION 3. If any section, subsection, paragraph, sentence, clause, or phrase of this Ordinance is for any reason held by a court of competent jurisdiction to be unconstitutional or invalid, the remaining portions of this Ordinance shall remain in full force and effect. The City Council hereby declares that it would have passed each section, subsection, paragraph, sentence, clause or phrase of this Ordinance irrespective of the unconstitutionality or invalidity of any section, subsection, paragraph, sentence, clause or phrase.

SECTION 4.

This Ordinance becomes effective thirty (30) days after its final passage and adoption.
