On March 20, 2024, we received your letter requesting a random signature verification of the 15,139 total signatures in the petition named above. The signature count includes the two officially withdrawn signatures but were not part of the random signature verification.

Upon the completion of the random verification the number of valid signatures is determined to be 379 out of 500 random signature sample. The statistical prediction of the valid signatures for this petition is calculated at 15% of the number required for the petition to be sufficient. A detailed breakdown is attached.

We request that you retrieve the petition for your retention at the earliest possible date. The petition is not a public record and may not be examined by anyone other than the public officer or public employees who have the duty of receiving, examining, or preserving the petitions. Pursuant to Election Code section 17200 the petition must be kept eight months after the final examination of the petition.
