**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,  
CALIFORNIA, HONORING THE RICHMOND TASK FORCE TO ELIMINATE  
GENDER-BASED VIOLENCE AND DIRECTING ACTIONS TO ADDRESS IT**

---

**WHEREAS**, the United Nations has designated November 25 as the International Day for the Elimination of Violence Against Women to raise awareness of violence against women and girls and to call for global action to end all forms of Gender-Based Violence; and

**WHEREAS**, the 16 Days of Activism Against Gender-Based Violence, spanning from November 25 through December 10, mobilize communities worldwide to take action to prevent and eliminate Gender-Based Violence; and

**WHEREAS**, Gender-Based Violence remains a pervasive issue in the City of Richmond, disproportionately impacting women, girls, and marginalized communities; and

**WHEREAS**, the Richmond Task Force to Eliminate Gender-Based Violence has worked together tirelessly since March of this year to raise awareness in Richmond around Gender-Based Violence (GBV), build sustaining collaboration with a coordinated approach, and create a set of recommendations on policies and practices to end GBV in Richmond that is informed by and centers the voices, lived experience, and leadership of survivors and community; and

**WHEREAS**, the Richmond Task Force to End Gender-Based Violence has grown into a coalition of over 44 Members - including survivors; community leaders; civic leaders; community-based organizations; and other community, public, and private stakeholders – as well as many supporters and continues to build partnerships and a movement with other community collective efforts including the Richmond Safety Stakeholders Association, birthed out of the Richmond Gun Violence Reduction Initiative; and

**NOW, THEREFORE, BE IT RESOLVED** that the City Council of the City of Richmond:

1. **Request** the City Manager designate a staff person to serve as the official liaison to the Richmond Task Force to Eliminate Gender-Based Violence and, in that capacity, to attend all Task Force Meetings and provide technical assistance, advice and support to the body, including:
  - **Allocates** six thousand dollars (\$6,000) over the next six months which will provide the material support and staffing necessary to finalize the Task Force’s recommendations, workplans and implementation strategy.
  - **Directs** the webmaster for the City of Richmond, California website to host, on the city’s homepage, a link to the anchor website for the Richmond Task Force to Eliminate Gender-Based Violence. This anchor website will serve as a centralized location where community members and stakeholders can learn about and connect with the Task Force’s work and access resources related to gender-based violence.
2. **Commits** to receiving a follow-up report from the Richmond Task Force to Eliminate Gender-Based Violence in approximately six-months’ time which will seek the City Council’s support for specific recommendations, workplans, and actions to end gender-based violence in Richmond.
3. **Directs** the City Manager to work with the Richmond Task Force to Eliminate Gender-Based Violence to review and consider the recommendations put forward by the task force and develop implementable action items, including but not limited to:
  - Allocating resources to support survivors of Gender-Based Violence and collective efforts to end GBV that center survivors and community.
  - Collaborating with relevant county agencies and non-profit and other community organizations to implement policies and practices to prevent and respond to Gender-Based Violence.
  - Supporting community-led initiatives aimed at eliminating Gender-Based Violence in Richmond.
4. **Commits** to holding itself accountable for progress by requesting a follow-up report from the City Manager by February 3, 2025, outlining specific actions taken and/or to be proposed for consideration for approval by the City Council.

**BE IT FURTHER RESOLVED** that the City of Richmond stands in solidarity with survivors, community, and all those working to end Gender-Based Violence and reaffirms its commitment to creating a city where everyone can live free from fear and violence.
