## DISCUSSION:

On December 6, 2022, City Council approved a two-year lease with U.S. Congressman John Garamendi for office space within the 440 Civic Center Plaza building and in space previously occupied by Congressman DeSaulnier (Attachment 1).

Congressman Garamendi has again requested the opportunity to lease approximately 845 square feet of the same office space (Attachment 2). This space serves as an excellent, central location from which to connect with the Richmond community and serves the West County area. The Congressman's staff would utilize space on the second floor of 440 Civic Center Plaza, adjacent to the reception area. The space includes one office space, four cubicles, conversion of one of the conference rooms for office space, and shared use of conference and break rooms.

Under the lease, the Congressman would pay rent of \$1,140.75 per month (\$1.35 per square foot) for a total of \$13,689 annually. The term would be consistent with the two-year Congressional term of office. The base rent was originally calculated by staff researching similar office space rates in the City of Richmond on the commercial real estate marketplace website Loopnet. At the time of an updated lease, available rental locations were not comparable of quality and lease rates. City staff determined that the previous rental rate of \$1.35 per square foot remains fair market value and supports this base rent rate.
