SUBJECT:	Memorandum of Understanding (MOU) with Pogo Park	
FINANCIAL IMPACT:	The MOU proposes to formally establish the City of Richmond and Pogo Park's financial responsibilities related to operations, programming and maintenance. Costs attributed to the City of Richmond will be incorporated into its standard budgeting process. The continued contributions by Pogo Park in relation to ongoing programming and operations has increased the activities and security of the parks and facilities. The organization seeks funding for the programming and operations activities they lead. The creation and execution of the MOU is one of the requirements for the allocation of \$3 million for the Harbour 8 Park Expansion Project.

A final draft version of the MOU ha been completed for City Council consideration and approval.	
RECOMMENDED ACTION:	RECEIVE an update on the Harbour 8 Expansion Project, APPROVE a Memorandum of Understanding (MOU) between the City of Richmond and Pogo Park, and AUTHORIZE the City Manager or their designee to make any changes necessary to operationalize the MOU – Community Services/Public Works (LaShonda White 510-620-6828/Daniel Chavarria 510-620-5478).	

DISCUSSION:

On June 17, 2025, the City Council authorized \$3 million from the Fiscal Year 2025-26 budget for the Harbour 8 Park Expansion Project contingent upon meeting the following criteria. A status update on each item is also included in the table below.

<u>Criteria</u>		<u>Status</u>
1.	Execution of a formal Memorandum of Understanding (MOU) between the City of Richmond and Pogo Park	Draft MOU is complete and attached. City staff and Pogo Park can amend the MOU, upon mutual agreement, as needed.
2.	Submission of the original and revised project budgets, including line-item detail for each cost overrun, broken down by change order number	Pogo Park submitted detailed project budgets and cost increases due to change orders for the Harbour 8 Expansion Project to City staff.
3.	Resolution of the kitchen scope and identification of its dedicated funding source	Pogo Park confirmed that the commercial kitchen (design and construction) is funded by the \$10 million Community Resilience Center grant.
4.	Confirmation that all applicable grant deadlines can still be met	Pogo Park staff are working diligently to meet grant deadlines. City staff will continue to work with Pogo Park to oversee and manage grant deliverables.
5.	A formal meeting between City staff and the Pogo Park Board to review and align project roles	City staff had an initial meeting with members of Pogo Park's board to discuss each entity's roles, the partnership, the MOU, etc.

Pogo Park, founded in 2007, is a community development corporation and 501(c)3 nonprofit based in Richmond, California, with a mission to transform under-utilized Richmond city parks into safe, beautiful, and green public spaces for children to play and the community to come together. Since 2007, Pogo Park has planned, designed, improved, programmed, and operated the facilities, serving as the steward of the facilities and has provided vital community services and programs for the benefit of Richmond residents.

Status of the Memorandum of Understanding

As one of the requirements for the allocation of \$3,000,000 for the Harbour 8 Park Expansion Project, City staff and Pogo Park developed a MOU to formalize the successful public/private partnership between the City of Richmond and Pogo Park regarding the following facilities: Harbour-8 Park, Harbour Hall, the Harbour-8 Commercial Kitchen, Elm Playlot and the Yellow Brick Road (Attachment 1). The MOU addresses operations, programming, staffing, maintenance, capital improvements, fundraising, and stewardship of the facilities, as well as processes for coordination, dispute resolution, reporting, and termination.

The purpose of the MOU is to provide a comprehensive framework that enables the City of Richmond and Pogo Park to collaborate efficiently and transparently to maintain the Facilities in a safe, clean, and fully operational condition; deliver equitable, community-driven programs and services; and leverage public and private resources to enhance neighborhood resiliency and quality of life. The MOU will assist in defining the relationship between the City of Richmond and Pogo Park to ensure that the goals of each are accomplished in a mutually supportive way.

The City of Richmond and Pogo Park are committed to ensuring that the facilities remain accessible, safe, and welcoming to all residents, prioritizing the needs of underserved communities, and thereby contributing to the City's goals of equity, diversity, and inclusion.
