

A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND, CALIFORNIA, AUTHORIZING THE EXECUTION OF COOPERATIVE AGREEMENT NO. 28W.05 WITH THE CONTRA COSTA TRANSPORTATION AUTHORITY (CCTA) AND PARTICIPATING WEST COUNTY JURISDICTIONS AND TRANSIT PROVIDERS, AND ACCEPTANCE AND APPROPRIATION OF \$180,000 IN MEASURE J PROGRAM 28B SUBREGIONAL TRANSPORTATION NEEDS FUNDS

WHEREAS, the voters of Contra Costa County approved Measure J, which established the Subregional Transportation Needs Program (Program 28b) to provide flexible funding for local transportation priorities in West Contra Costa County; and

WHEREAS, the West Contra Costa Transportation Advisory Committee (WCCTAC), on July 25, 2025, recommended the appropriation of a total of \$660,000 in accumulated Program 28b funds to nine West County jurisdictions and transit providers for various transportation improvements; and

WHEREAS, pursuant to this recommendation, the City of Richmond is allocated \$180,000 for programmatic sidewalk improvements and other eligible transportation safety projects that align with Program 28b guidance; and

WHEREAS, the Contra Costa Transportation Authority (CCTA) is the administrating agency responsible for disbursing these funds through a formal agreement; and

WHEREAS, the CCTA has prepared Cooperative Agreement No. 28W.05 to formalize the allocation and establish the terms, including the requirement that the funds be expended no later than July 1, 2027; and

WHEREAS, City staff recommends that the City Council authorize the execution of Cooperative Agreement No. 28W.05, accept and appropriate the \$180,000 in measure J program 28B Subregional Transportation Needs funds.

NOW, THEREFORE, BE IT RESOLVED by the council of the City of Richmond as follows:

Section 1. The City Council finds the above recitals are true and correct and have served, together with the accompanying Agenda Report, as the basis for the findings and actions set forth in this Resolution.

Section 2. The City Council authorizes the City Manager or their designee to execute Cooperative Agreement No. 28W.05, and any non-substantive amendments thereto, between the City of Richmond and the Contra Costa Transportation Authority, Contra Costa County, the Cities of El Cerrito, Hercules, Pinole, and San Pablo, and transit providers (BART, AC Transit, and WestCAT).

Section 3. The City Council hereby accepts and appropriates \$180,000 in Measure J Program 28b funds into the Engineering Grant Fund (Fund 1054) to support programmatic sidewalk improvements and other eligible transportation safety projects.

Section 4. The City Council designates the City Clerk as the custodian of the documents and other materials that constitute the record of proceedings upon which the decision herein is based. These documents may be found at the office of the City Clerk at Richmond City Hall, 450 Civic Center Plaza, Richmond, California 94804.

Section 5. This Resolution shall become effective immediately upon its passage and adoption.
