**A RESOLUTION OF THE CITY COUNCIL OF THE CITY OF RICHMOND,  
CALIFORNIA, APPROVING A PURCHASE WITH JESSE MACK COMPANY  
AND STERLING MAY EQUIPMENT COMPANY FOR THREE (3) FUEL-  
REDUCTION MOWING UNITS FOR WEED ABATEMENT AND DEFENSIBLE-  
SPACE OPERATIONS IN AN AMOUNT NOT-TO-EXCEED \$269,747.62,  
PURSUANT TO RICHMOND MUNICIPAL CODE SECTION 2.52.320  
(PIGGYBACK PROCUREMENT)**

**WHEREAS**, the City of Richmond Public Works Department is responsible for citywide vegetation management, fuel-reduction, and defensible-space maintenance along rights-of-way, hillside corridors, and critical infrastructure areas; and

**WHEREAS**, current operations rely heavily on manual brush cutting and hand trimming on steep and uneven terrain, which increases safety risks to staff, limits operational efficiency, and restricts the acreage that can be maintained during peak fire season; and

**WHEREAS**, the City desires to enhance worker safety, improve operational efficiency, and advance sustainability goals through the acquisition of mechanized slope-mowing equipment; and

**WHEREAS**, staff evaluated available procurement options and identified Jesse Mack Company and Sterling May Equipment Company as the most advantageous vendors for the acquisition of one (1) Green Climber LV600 remote-control mower and two (2) Raymo Torpedo electric slope mowers, including accessories and one spare battery; and

**WHEREAS**, the proposed purchase is intended to be made through piggyback procurement, pursuant to Richmond Municipal Code Section 2.52.320, utilizing Sourcewell Contract No. 032525-GCL, a contract competitively solicited and awarded by a public agency; and

**WHEREAS**, in accordance with Richmond Municipal Code Section 2.52.320, staff independently reviewed the Sourcewell solicitation and resulting contract and determined that: (a) the originating contract was competitively solicited by a public agency; (b) the scope, specifications, and pricing of the contract are suitable for the City's intended use; (c) the contract remains active and in good standing; and (d) utilizing the existing contract is in the City's best interest and provides cost savings and administrative efficiency compared to conducting a separate solicitation; and

**WHEREAS**, staff further determined that no local vendors offer comparable equipment meeting the City's slope-safety, terrain-access, and zero-emission operational requirements, and that the equipment available through the Sourcewell contract represents the most advantageous solution available to the City; and

**WHEREAS**, the total cost of the proposed purchase, including tax and shipping, shall not exceed \$269,747.62 and is funded through the approved Fiscal Year 2025-2026 Public Works Operations and Maintenance budget (Account No. 50336031-400705-03D04);

**NOW, THEREFORE, BE IT RESOLVED** by the City Council of the City of Richmond, California, that the Council hereby approves a purchase with Jesse Mack Company and Sterling May Equipment Company for the acquisition of one (1) Green Climber LV600 remote-control mower and two (2) Raymo Torpedo electric slope mowers, including accessories and one spare battery, in an amount not-to-exceed \$269,747.62, pursuant to Richmond Municipal Code Section 2.52.320 (Piggyback Procurement) and Sourcewell Contract No. 032525-GCL.
