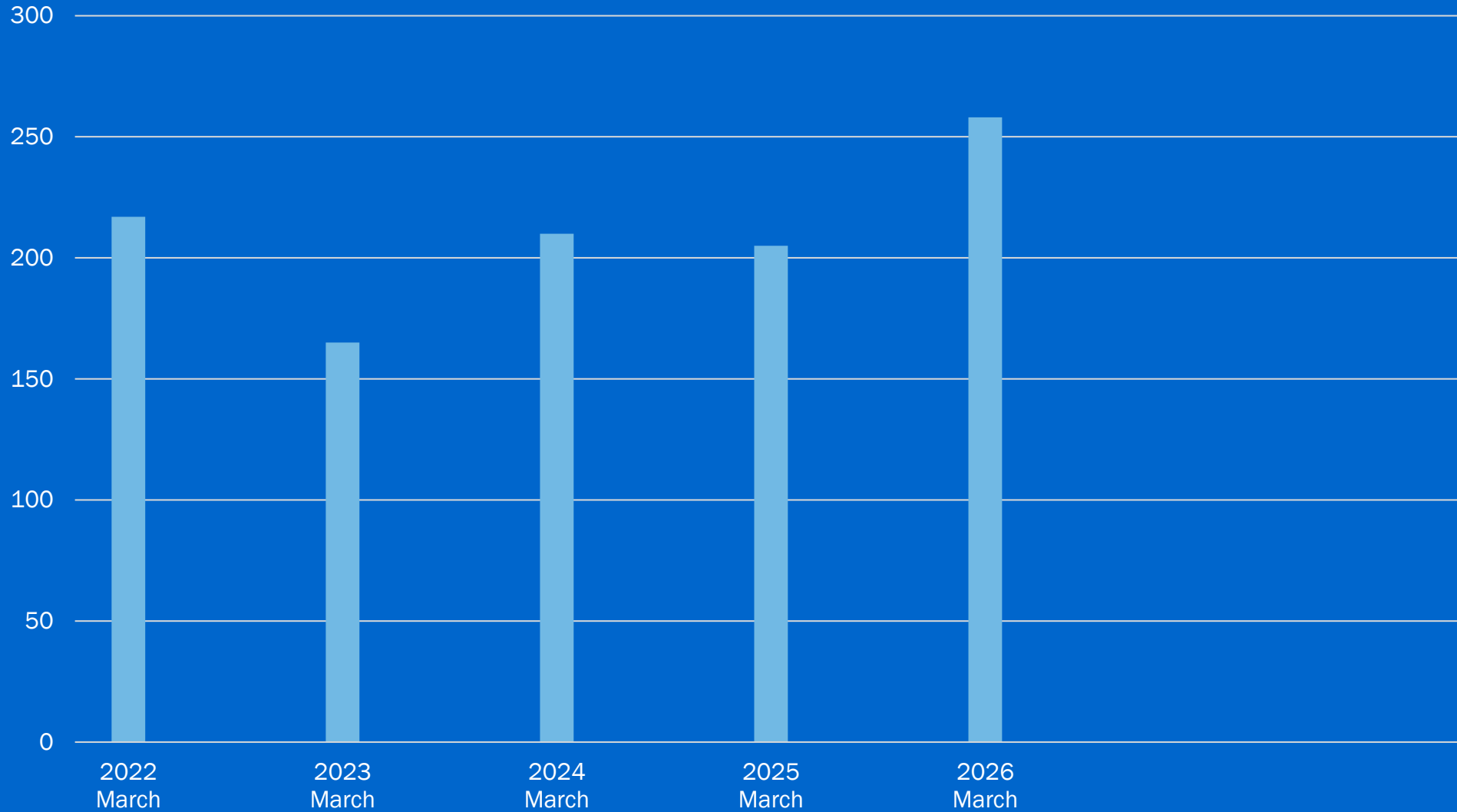

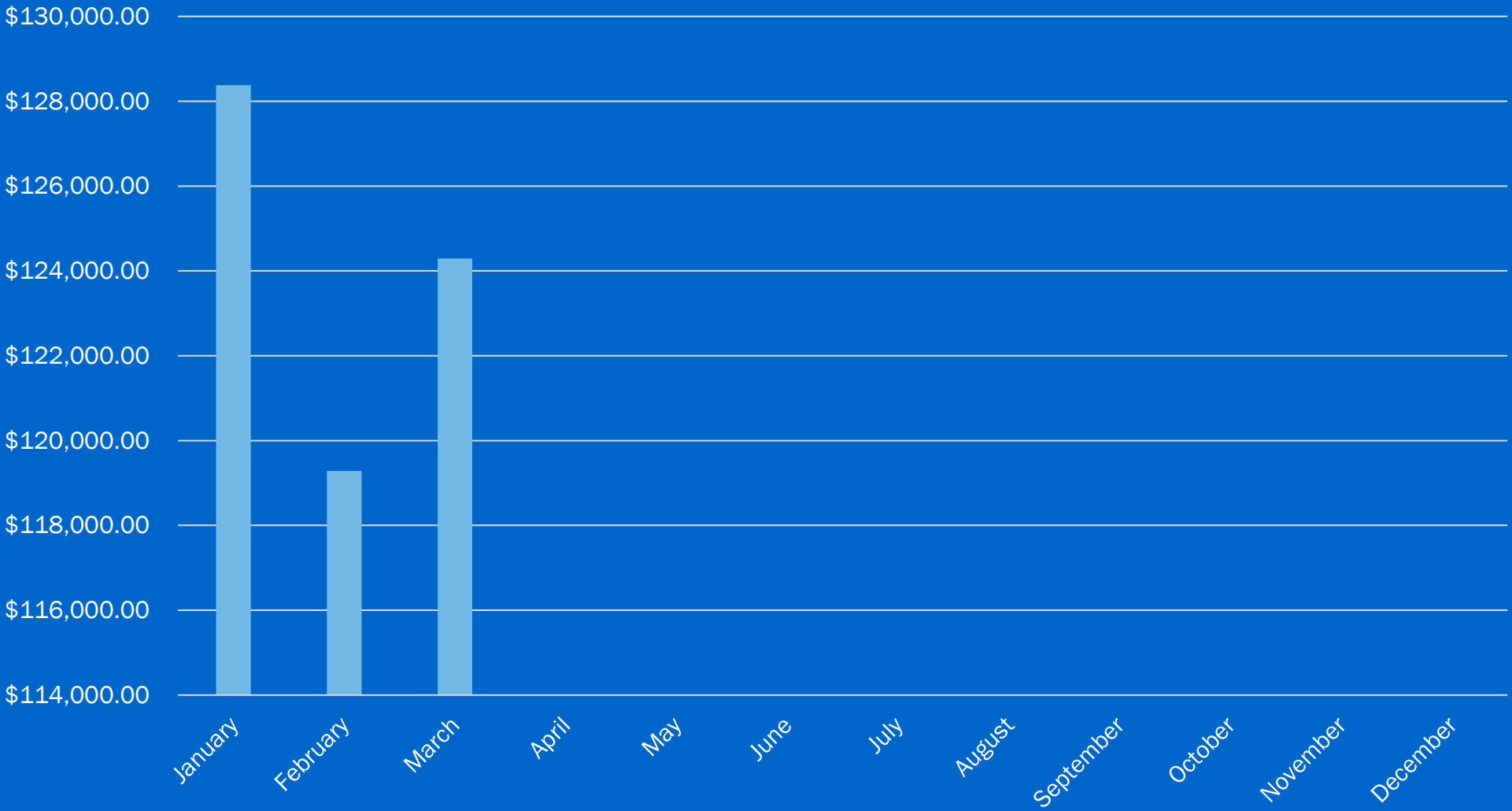

# MATTRESSES COLLECTED PER MONTH

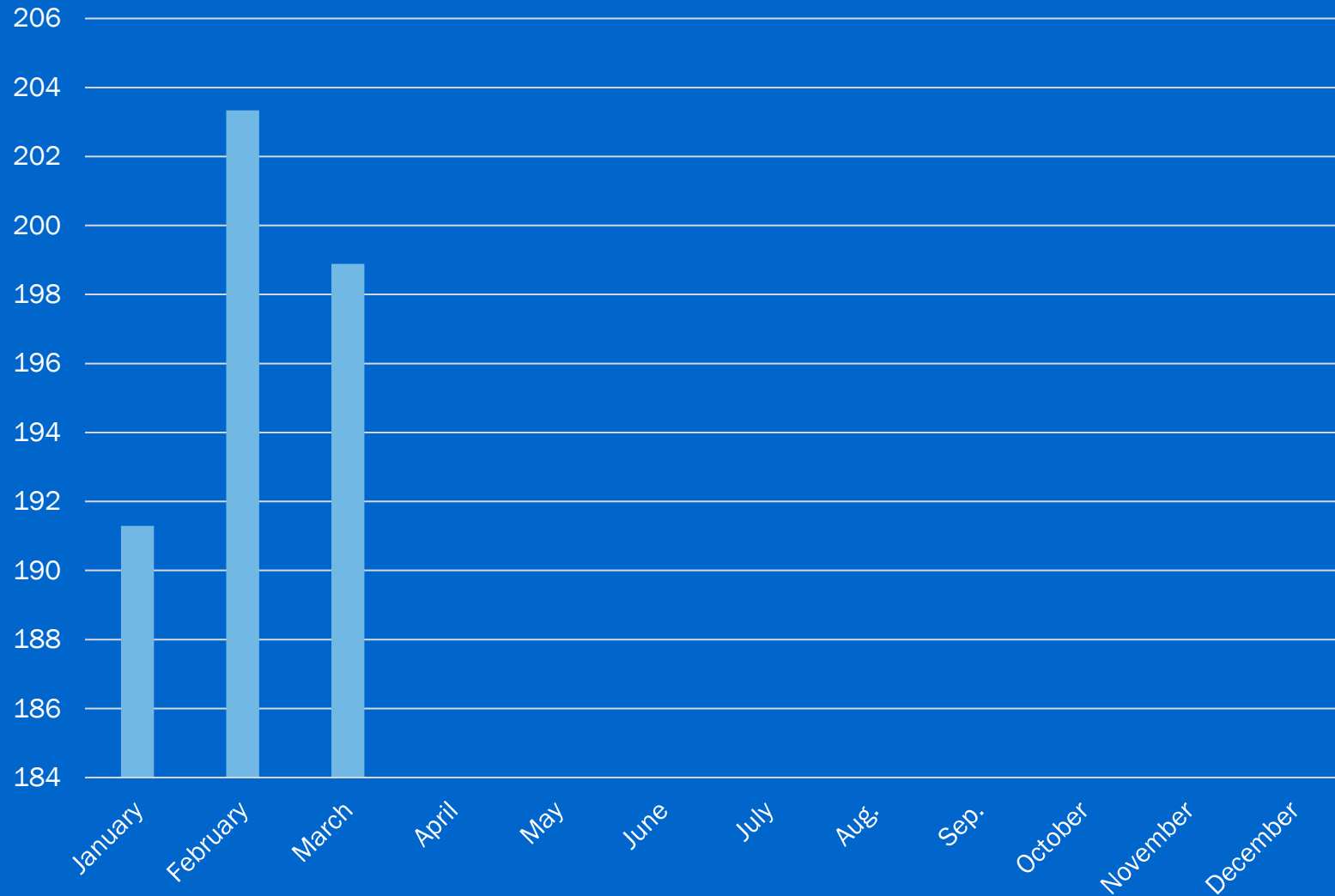


# ILLEGAL DUMPING TOTAL COST PER MONTH – 2026\*

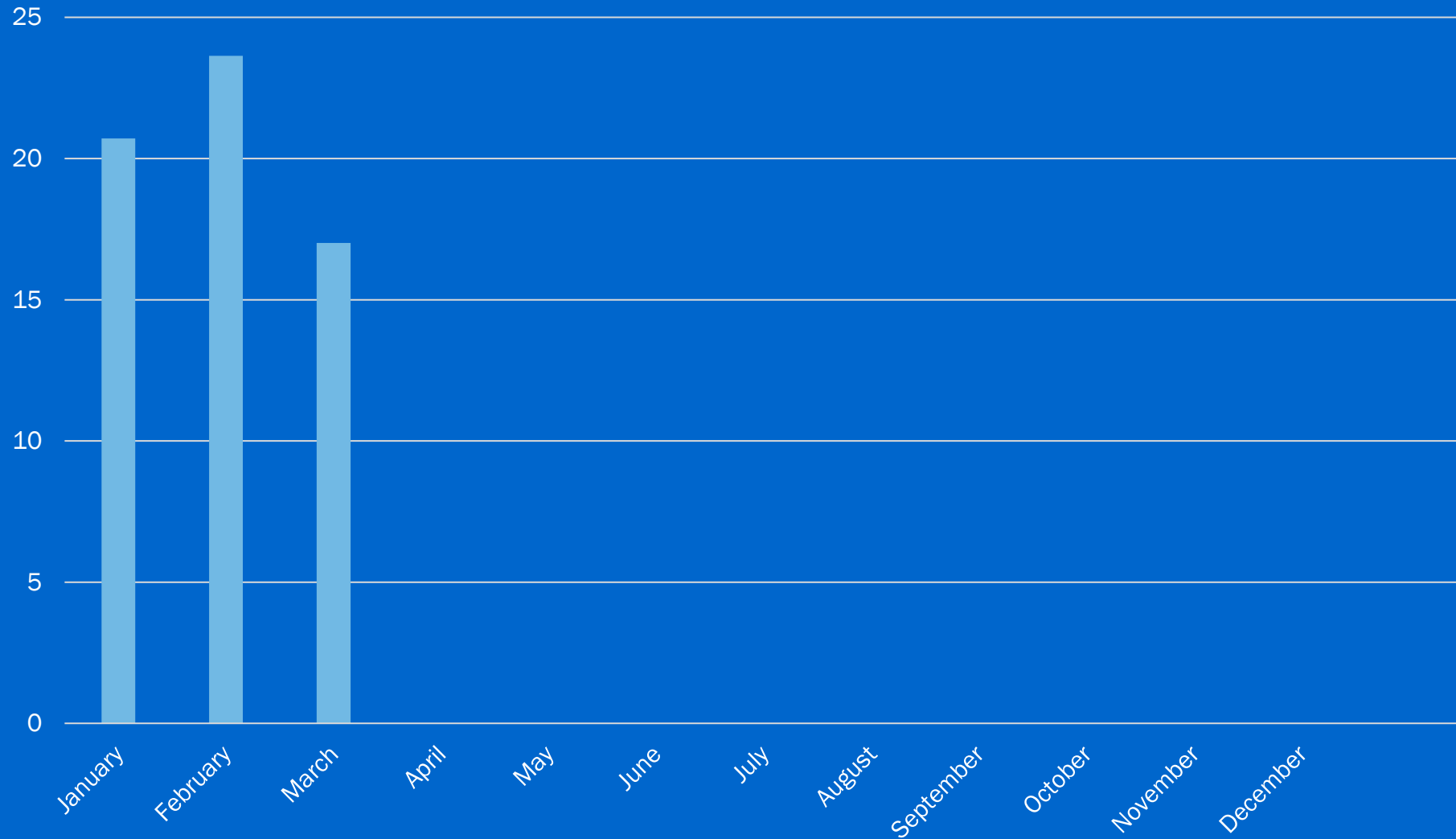

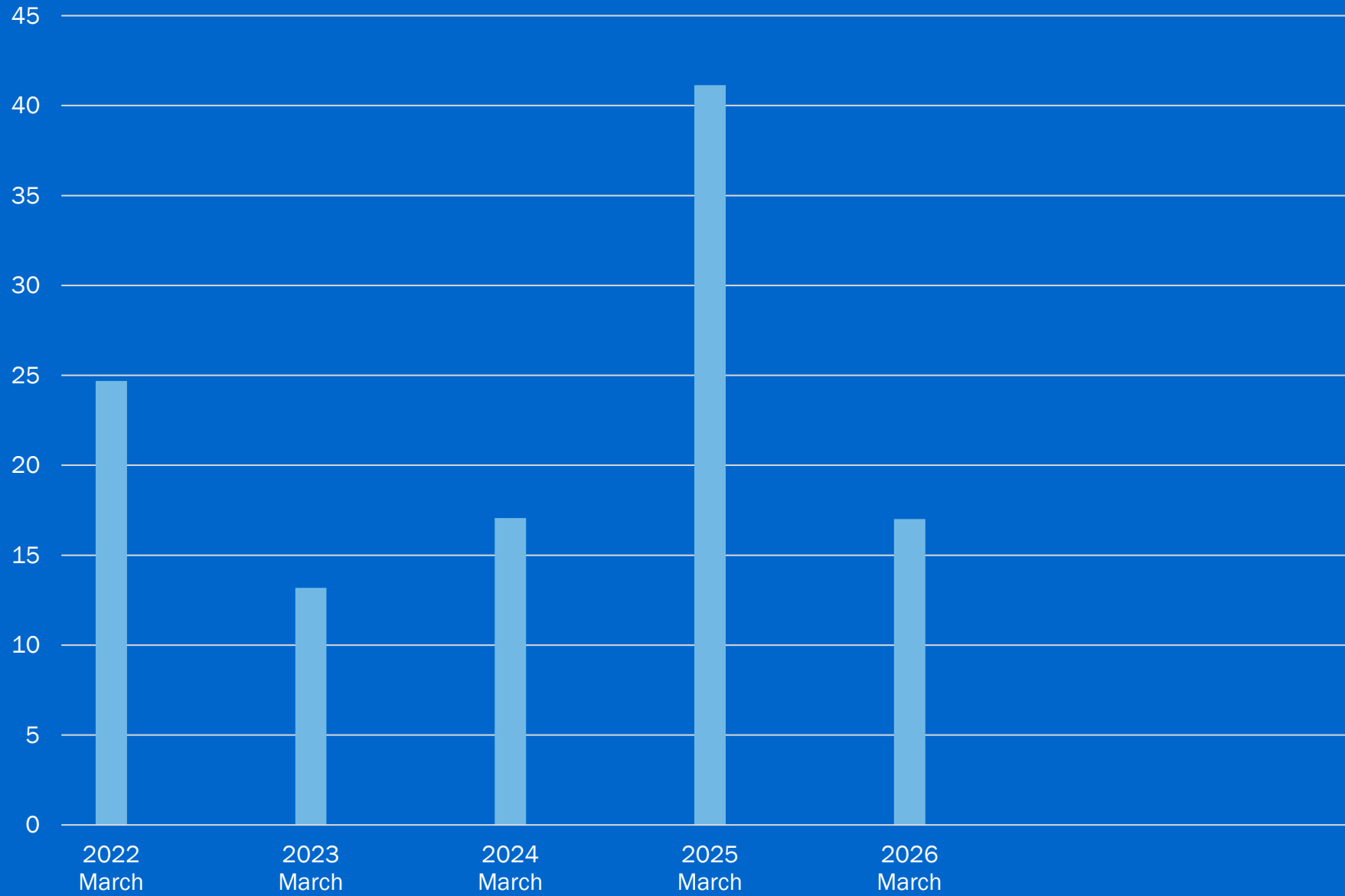
