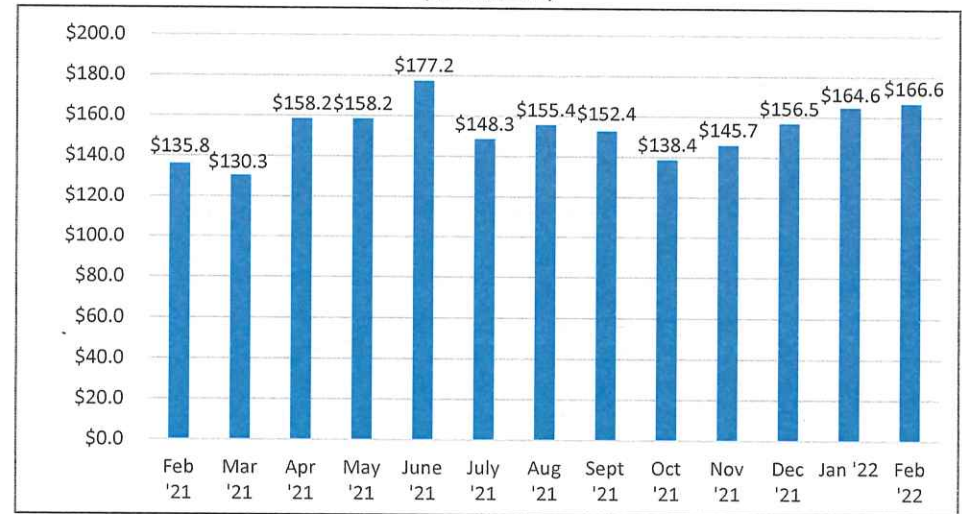

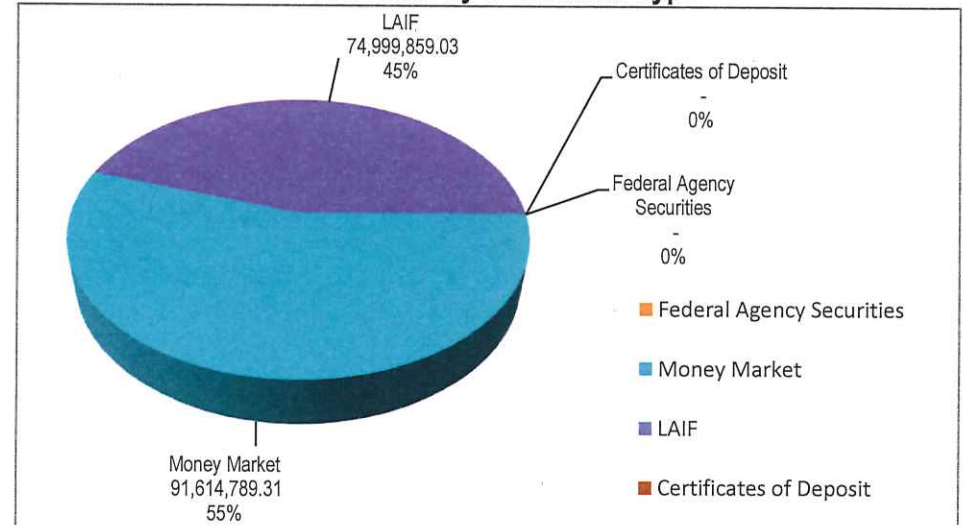
Book Value History
